Waiver of Liability

(hereinafter "XKO") shall not be liable for any damage or personal injuries sustained by any person in, on or about the premises or Texas Live - Arlington Backyard venue (1650 E Randol Mill Rd, Arlington, TX 76011) or The Factory venue (2713 Canton St, Dallas, TX 75226) or Knockout Live Venue (1520 Nolan Ryan Expy, Arlington, TX 76011) or The Statler (1914 Commerce St, Dallas, TX 75201). Participant does hereby release and discharge BAP and/or XKO, and/or Texas Live/Arlington Backyard venue and/or The Factory venue and Knockout Live in Arlington and/or The Statler from any and all claims, demands or actions arising out of the participation and/or use of or intended use of its facilities, services or equipment, including, without limitation, any claim for personal injuries, resulting from or arising out of the negligence of BAP and/or XKO, its owners, affiliates, agents or employees.
